Wing Limited Special Bank, one of Cambodia's leading mobile banking service providers, and South Korean Woori Bank have signed a memorandum of understanding to allow real-time money transfers between Cambodia and South Korea. .The service is expected to launch towards the middle of the year, according to а statement from Wing on Tuesday."Once the service available, Cambodians who live in South Korea will be able to transfer money to Cambodia on a real-time basis through the Woori global banking application, visiting a bank branch, or using automated machines with only an account number and mobile phone number," Wing said. The number of Cambodian immigrants living in South Korea is estimated at 40,000, it said, adding that both companies expect this figure to continue rising in upcoming years. Wing provides bill payments and phone top-ups through more than 6,000 outlets throughout the Kingdom. Users can receive remittances from Australia, Singapore, Japan, and Thailand. The agreement is part of Woori's strategy to strengthen its presence in Southeast Asia. In April, Woori signed an agreement with local telecommunications company SK Telink to expand its offer of digital services..

## China, Laos ink deal on business development

VIENTIANE, May 28 (Xinhua) -- The Lao National Chamber of Commerce and Industry (LNCCI) and the All-China Federation of Industry and Commerce (ACFIC) have inked a cooperation agreement that formalizes the close working relationship between the two organizations in the future.Under the framework of the China-proposed Belt and Road Initiative, the two countries have agreed to comply with the laws and regulations of Laos and China, local daily Vientiane Times reported on Tuesday.

A Memorandum of Understanding (MOU) on the principle of equality and mutually beneficial cooperation was signed by LNCCI President Oudet Souvannavong and Executive Vice Chairman of ACFIC Xu Lejiang, in Lao capital Vientiane. The MOU was signed during a visit to Laos by a Chinese delegation who were primarily meet to businesspeople, especially representatives of smalland medium-sized enterprises.Significant cooperation could be established between the business sectors of the two nations because the two governments have built a strong and close working relationship, the local daily quoting Oudet as saying."Under the newly signed agreement, the private sectors of Laos and China will focus on developing industry in various parts of the northern provinces. This industry will help ensure that the Lao people benefit from the Laos-China railway and the new expressway," he said.Oudet said the meeting enabled Lao and Chinese businesspeople to interact with each other and promote cooperation in future investment projects."After the signing of the cooperation agreement, an office for the Laos-China Business and Investment Committee will soon be established at LNCCI as a point of contact for the Lao and Chinese business communities," Oudet added.The Chinese business delegation is on a working visit to Laos from Sunday to Tuesday. The delegation will also visit Cambodia's capital Phnom Penh on Wednesday. Enditem.

# Telenor, Axiata merger could result in better services for Myanmar

Norway's Telenor Group and Malaysia's Axiata Group are planning to combine their telecom operations in Asia, according to Telenor Myanmar Company. Both aim to create a well diversified telecommunications company with operations across nine countries, including Myanmar. Telenor is expected to own 56.5 percent of the merged entity, while Axiata will own the remaining 43.5pc. "We're discussing a merger and will announce it once an agreement is reached. If successful, the merger would result in one of the biggest telcos in Asia in terms of infrastructure and number of users, which will amount to 300 million in Asia," said Ma Shwe Yin Mar Oo, external communications manager at Telenor Myanmar. This will lead to better overall services for Myanmar. Telenor's aim of cooperating with Axiata is to increase its exposure to communications networks and technologies like 5G, Internet of Things and Artificial Intelligence.. Telenor Myanmar currently has 18.4 million local users; 62pc of which are data users. The average data usage of a person is 2.7 GB, according to the company. Among the 8300 Telenor towers in Myanmar, more than 6000 are 4G or Long Term Evolution (LTE) towers. Telenor has invested US\$ 2.7 billion in Myanmar and is the second largest telco in the country.

## Việt Nam, Ivory Coast eye co-operation

HCM CITY - Standing Vice Chairman of the HCM City's People Committee Lê Thanh Liêm on Monday discussed measures to promote bilateral cooperation, particularly economic, with minister and secretary general of the presidency of the lvory Coast, Achi Patrick. He believed that the visit by the West African guest would help boost economic ties and friendship between Viêt Nam and the Ivory Coast. Highlighting the thriving bilateral trade, which recently exceeded US\$1 billion and made lvory Coast Viêt Nam's top trade partner in Africa, he described the country as a promising market for Vietnamese agricultural products and an important raw materials supplier for Viêt Nam. HCM City is prioritising high-tech agriculture and bio-technology to achieve value-addition and the two sides have huge potential for collaboration, he said. Patrick said he was impressed by the city's dynamism, and hoped to learn from Viêt Nam's experience in national construction and development, including poverty alleviation and attraction of foreign investment. He said the two sides should work together in agriculture, including aquaculture, for mutual benefit. Promoting cashew processing lvory Coast has 1.4 million hectares under cashew and is

### US ban on Huawei unlikely to affect Viet

HA NOI — US restrictions on Huawei are unlikely to affect the Vietnamese smartphone market or phone retailers.According to the latest market strategy report by the VNDirect Securities Co, Huawei's smartphone market share in Việt Nam was only 4 per cent and worth VNĐ2.65 trillion (roughly US\$114 million) last year.Besides, though Huawei was the world's second largest seller last year, the brand is not too strong in Việt Nam and there are many substitutes in the mid-range price category such as

Oppo, Xiaomi and Nokia, it said. The market is dominated by Samsung, Oppo and Apple with respective shares of 41.1 per cent, 22.7 per cent and 8.6 per cent. Another Chinese brand. Xiaomi, had a 6 per cent share, it showed. On May 15, the US Commerce Department placed Huawei and its 70 affiliates on a trade blacklist, making it harder for the Chinese telecom giant to buy parts and components from US companies. A study by GCS-CIMB predicts this ban would drive down Huawei's smartphone sales in international markets by 40 per cent year-onvear in 2019, while sales of Oppo and Xiaomi would surge 60 per cent and 43 per cent.In Viêt Nam, VNDirect expects an insignificant effect on FPT Retail and Th $\hat{e}$  gi $\hat{o}$  di  $\hat{d}\hat{o}$ ng (Mobile World), the two retailers distributing Huawei.For them, sales of Huawei smartphones account for just 4-6 per cent of total sales. But both retailers face inventory risk and have ongoing contracts for installment payment of Huawei products.VNDirect mentioned two possible scenarios: Huawei and its partners would share costs and liquidate the inventories by reducing prices and promotions or Huawei would buy back the stocks from partners like Samsung did with Galaxy Note 7 after the battery incident.Both FPT Retail and Thế giới di động are awaiting discussion with Huawei for optimal solution. In the unlikely case that Huawei does not support its partners, the latter would have to make provision for its current stocks of Huawei's products. **độ**ng and VNĐ40 billion for FPT Retail, or 3.8 per cent and 11.5 per cent of their net profits in 2018, according to VNDirect's estimates.Meanwhile, Digiworld is likely to benefit from this incident, since its main products are Nokia and Xiaomi, and any decline in Huawei sales would boost sales of those two brands. — VNS
