

International tourists to Cambodia shoot up 211%

Cambodia welcomed 3.92 million international tourist arrivals during the first nine months of 2023, surging 211% year on year, the country's Ministry of Tourism said on Friday. Thailand topped the sources of international arrivals, followed by Vietnam and China. The three countries posted the respective growth rates of 189%, 156%, and 549% in the numbers of visitors to Cambodia, according to the ministry's report. Meanwhile, 1.34 million foreign tourists visited Cambodia by air, up 186%, and 2.58 million by land and waterways, up 224%. Top Sopheak, Secretary of State and Spokesman of the Tourism Ministry, said the country expects to receive at least 5 million international arrivals this year. He voiced his belief that more international tourists will be attracted to Cambodia after Siem Reap Angkor International Airport becomes operational on October 16. Tourism is one of the four pillars of the Cambodian economy, in addition to garment, footwear and travel goods export; agriculture; and construction and real estate.VNA

MoC join hands with Chinese IT firms to boost economic growth

Registration on MyRO required for grain storage facilities

The Ministry of Commerce notified that grain storage facilities need to be registered on the online registration platform – Myanmar Rice Online (MyRO) www.myro.com.mm, starting 3 November 2023, intending to ensure rice self-sufficiency, systematic export, price stability and systematic registration for grain storage and implementing warehouse receipt financing system. The owners of the grain storage facilities for above 5,000 baskets of paddy and 1,000 rice bags (over 50 tonnes) are included in seeking this registration. For further details on registration, the Department of Consumer Affairs can be reached at phone numbers 067 3430563, 067 3430131 and Myanmar International Trade Centre through the phone number 01 385323 and address No 622/626, Merchant Street, Pabedan Township, Yangon. The Commerce Ministry, in cooperation with the Myanmar Rice Federation, held a Go-Live ceremony for the Myanmar Rice Online (MyRO) Website and a meeting regarding the MyRO registration platform for grain storage facilities at Thingaha Hotel in Nay Pyi Taw on 3 November. At the meeting, Deputy Prime Minister Union Minister for Planning and Finance U

Win Shein remarked that this meeting highlighted the implementation of the work processes of Myanmar Rice Conference 2022 such as the crop insurance system for farmers and the enhancement of the rice sector. This MyRO system is aimed at facilitating the registration of grain storage facilities, exporter licences and rice mill registration through digital platforms. It will provide an easy, quick and efficient registration system like company registration. This ceremony is intended to be a first step for the rice sector to move forward to digital transformation. The State will help provide policy stability to ensure an enabling environment for investment. Public-Private Partnership to bring greater harmony plays a pivotal role in the development of the State's economy. Afterwards, Union Minister for Commerce U Tun Ohn stated that the ministry is joining hands with the private sector to benefit the farmers, make a reasonable profit for millers and traders, lessen the burdens of the consumers, ensure self-sufficiency and enhance exportation. Following the Myanmar Rice Conference 2022, the ministry achieved to carry out the 43 prioritized work processes. A workshop was held to implement the Warehouse Receipt Financing System and decided on 12 work processes for further activities. Under the approval of the SAC, a task force to implement a warehouse receipt financing system was formed. Drawing up further plans, laying down policies, rules, regulations and standards, creating a separate fund, conducting pilot projects and supporting domestic and foreign businesspersons who want to invest in warehousing

will be effectively implemented. The pilot project is planned to kick off in Nay Pyi Taw Union Territory, Yangon, Ayeyawady, Bago and Mandalay regions. The MyRO will disseminate information for those stakeholders in the rice industry including farmers, merchants, rice millers, exporters, experts and consumers and facilitate the registration process. Thus, all the stakeholders in the industry are encouraged to cooperate in this effort, U Tun Ohn elaborated.

Industrial production index up 0.5% in ten months

Hanoi (VNA) - Vietnam's index of industrial production (IIP) edged up 0.5% in the first ten months of this year with the October IIP alone rising 4.1% year-on-year, according to the General Statistics Office. Phi Thi Huong Nga, head of the Industry and Construction Statistics Department said that although the production and business activities of enterprises in the processing, manufacturing, and mining industries are still facing difficulties, they have recovered more positively than the third quarter of 2023. Some key industries registering increases in IIP in the first ten months of this year included rubber and plastic products (up 9.5%); tobacco (9.1%); prefabricated metal products except machinery and equipment (8.7%); metal ore exploitation (6.3%); food processing and production (6.1%); chemicals and chemical products (5.9%); water exploitation, treatment and supply (5.3%). Meanwhile, the IIP of some manufacturing industries decreased such as other means of transport (7.3%): motor vehicles (4.1%); crude oil and natural gas exploitation (4%); other non-metallic mineral (3.7%); paper and paper products (2.7%). According to the GSO, compared to the same period last year, 49 localities posted increases in their IIP while 14 localities saw decreases. Some localities have seen a fairly high increase in the IIP due to a sharp increase in the processing and manufacturing industry, electricity production and distribution industry including Dak Lak (36.9%), Bac Giang (18.6%), Phu Tho (16.8%), Nam Dinh (14.4%), Kien Giang (14%) and Hai Phong (13.5%) The number of workers working in industrial enterprises as of October 1, 2023, increased by 1.0% compared to the same time last month and decreased by 1.4% compared to the same time last year. Particularly, the number of workers in the Stateowned enterprise sector remained unchanged compared to the same time last month and decreased by 0.9% year on year. However, the number of workers in non-state enterprises increased by 0.6% and decreased by 2.8% respectively; the number in foreign-invested enterprises increased by 1.2% and decreased by 0.9% respectively

Ten-month retail sales of consumer goods, services up 9.4%

Hanoi (VNA) - Vietnam's total retail sales of consumer goods and services saw a year-on-year increase of 9.4% to more than 5.1 trillion VND (207.8 million USD) during January - October, the General Statistics Office said. Revenue from retail sales of goods was nearly 3.99 trillion VND, accounting for 78.1% of the total and up 8.3% year-on-year. Notably, revenue from tourism surged 47.6% to an estimated 30.2 trillion VND as localities nationwide have carried out an array of tourism offerings as well as cultural and sport activities to stimulate travel demand. Strong rise in revenue from retail sales of goods and services was seen in several localities, including Da Nang (143.8%), Khanh Hoa (137.9%), Quang Ninh (94.9%), Ho Chi Minh City (68%), Hanoi (59.5 %), Hai Phong, (47.35%) and can Tho (32.4 %). Experts said that revenue from retail sales is expected to rise until the end of this year on the back of economic recovery and acceleration of public investment disbursement. However, as domestic consumption remains weak and is on a sluggish recovery due to the lingering impacts of the COVID-19 pandemic, it is necessary to sketch out rational solutions and attractive programmes to lure more foreign tourists, and bolster domestic tourism so as to fuel consumption. Over the past time, an array of implemented by incentives has been Government to encourage spending, comprising

organisation of discount programmes, reduction of interest rates and personal income tax, and enhanced social welfare support. The Ministry of Industry and Trade will join hands with competent ministries, sectors and localities to keep a close watch on the market situation, ensure sufficient essential items, and stabilise the market during yearend holidays.
